2. Delivery to the headquarters of the Ordering Party at 107 Szubińska St., 85-915 Bydgoszcz at cost and the risk of the Contractor.

#### **V. The term in which the Bid remains binding**

1. The bid remains binding for the period of: 30 days.
2. The period of the bid being binding begins with the expiry of the deadline for submitting bids.
3. At least 5 days before the deadline for binding the offer, the Ordering Party may ask the Contractors to agree to the extension of this deadline of a designated period.

#### **VI. The bid preparation method description**

1. The bids must be submitted in paper form on the bidding form annexed to the Tender Notice (Order Announcement).
2. In addition to the paper form of the offer, attach an electronic version (scan of the complete offer on a CD).
3. The offer form must be filled out legibly in the Polish language.
4. The priced bid should include all costs related to the execution of the subject of the order.
5. The bid and all required attachments must be signed by the Contractor or person(s) authorized to represent the Contractor.
6. If the right to representation of the person signing the bid does not result from the attached documents, the bid should also be accompanied by a power of attorney in the original or in the form of a notarized copy in writing.
7. Any amendments to the bid must be legible and signed by the person signing the bid.
8. The Ordering Party does not allow the submission of partial bids.
9. The Ordering Party shall not be liable for events resulting from improper labelling of the envelope/package or lack of any of the required information.

#### **VII. Location and term of bid submission**

1. The bid together with the required documents must be submitted within the deadline of: **28.02.2025 by 2.00 p.m.** in sealed envelopes with the following note:
