- > supervising the certification process and all maintenance tasks in the field of line and base maintenance;
- > organizational and technical preparation to perform the ordered line and base maintenance services and supervision over their performance in accordance with EASA aviation regulations and the provisions of MOE;
- > cooperating with the Quality Manager and Safety Manager in organizing the system of collecting and analyzing information about the malfunctions of aviation equipment and taking actions to improve the quality of the equipment;
- > cooperating with the Aviation Authority in the field of continued compliance of the Maintenance Organization with applicable regulations, standards and procedures contained in the Characteristics / MOE /;
- > overseeing the scheduling of repairs and maintenance;

- > fluency in English is essential, knowledge of Polish will be an additional advantage;
- > knowledge of aircraft operations, maintenance systems and procedures;
- > comprehensive knowledge of EASA regulations in relation to aircraft operations, inspection and maintenance regimes;
- > ability to be an effective hands-on manager self-motivated and results oriented with a focus on safety and quality;
